04/22.3 – Bowls Club Lease:

Following extensive research Cllr Peach provided the meeting with options to move forward with the new lease. Following a discussion, it was agreed to recommend to OM that costs relating to a Valuation and a Solicitor to draw up new lease are estimated at £2200. The issue that the new lease may not be completed by the expiry date could be covered by a Hold Over Lease on a 6 - 12-month term. The estimate cost for this type of lease is £200, to be recommended to next OM.
