02/15.5 Chairman's Remarks:

- 5.1. Library: The group have received the first grant from The Headley Trust. Excellent progress is being made. N Lee gave a very good account on Radio Berkshire.
- 5.2. The Swan Hotel: Chairman has met with representatives of Group to put forward concerns from residents. They have agreed that the name of The Swan will still feature prominently on their signs. The petition against a name change raised 130 around the village and 270 on line.
- 5.3. BDBC are concerned over low recycling figures just 23%. There will be a leaflet drop campaign to try and encourage people to recycle more efficiently.

### 02/15.6 Speed Watch: Cllr Bond

Two practice sessions were held over the weekend and traffic visibly slowed down on seeing the group taking action. More volunteers would be welcome to share the work load

#### 02/15.7 Neighbourhood Plan: Cllr Adams

Representatives from one of the interested developers and owners of two parcels of land were at the last NP meeting on 2<sup>nd</sup> February. They put forward detailed proposals and could accommodate up to 42 house spread over the two sites of Coppice Road and Strokins Road. The concerns of parking need to be better addressed by developers. There was concern also over the proposed action for the Coppice Road site and alternatives are being looked at. We had a walkabout with representative from AECOM (formerly URS) at these two sites plus land available at Porch Farm. AECOM will be doing an evaluation of these plots for us.

Our Draft Scoping Report has been submitted to BDBC – this will tell us whether or not we will require SEA's on our sites. Strategic summaries will shortly be available on the website. The next move is to settle on sites and push on with our draft plan.

#### 02/15.9 Borough Councillors:

Cllr Sherlock submitted a written report which was presented by the Chairman and included:-

The Cabinet had settled on 845 dwellings per year for each of the 15 years of the programme in their revised draft Local Plan.

Completion is expected next Spring. There has been suggestion for the requirement of further building in the villages and hamlets – this is yet to be confirmed. There will be a seminar in March and it was requested that we ask if we can send a representative. Mr Packham attended a Police Meeting on our behalf and Cllr Sherlock has asked for details to be sent to him.
