<b>06/14.4</b>	<b>Matters arising:</b> 4.1: GP 06/14.4 – unanimously <b>Agreed</b> to amendments to M&M contract at a cost of £924pa. 4.2: GP 06/14.8 – We have been turned down for funding for the children’s play area by Veolia. Cllr Cruickshank to look for alternative funding.	<b>JC</b>
<b>06/14.5</b>	<b>Chairman’s Remarks:</b> i. Thanks were recorded to Baikies for replacing stolen hand rails at Cemetery steps FOC. ii Swan street will be closed for 2 to 3 days for repairs to the road and pavements. A diversion will be in place via Basingstoke. We have asked that they advise retailers and the stables exactly when as this is to be as it will affect their deliveries. Scheduled for end of July. iii Chairman reported on abuse he received whilst challenging someone putting up illegal notices. The company that hired the Contractors has been contacted and an apology received. Chair is considering further action. iv We have been asked to identify WW1 descendants in Kingsclere that could be invited to a special Borough reception in Basingstoke.	
<b>06/14.6</b>	<b>Route 56 - Update:</b> Cllr Savin advised on meeting with Basingstoke Community Transport and changes in the route which do not affect Kingsclere other than the travelling distances and therefore times were reduced. Two more Parishes have been approached to join the partnership. There is no immediate threat to the service as it is still highly successful in Kingsclere.	<b>TS/AD</b>
<b>06/14.7</b>	<b>Neighbourhood Plan:</b> <ul style="list-style-type: none"><li>• Cllr Adams reported that URS have been engaged as our Site Survey Contractor who will present their findings at a Public meeting later this year.</li><li>• A further “pared down” Questionnaire has been distributed with The Tower this month.</li><li>• SA called for Cllrs to help at the School Fete this weekend. There is also only one person as yet available for the Church Fete – more people are needed.</li><li>• There will be training in July from Planning Aid England to advise on how we can write up our policies for the NP.</li><li>• SA advised that we did not submit a response to the B&amp;D Local Plan consultation as development did not change and the only concerns were on traffic levels which will need to be controlled.</li><li>• We are still waiting for B&amp;D’s decision on whether or not we will require Strategic Environmental Assessments for our Plan but we are proceeding on the basis that these will be required.</li><li>• Next NP Meeting is scheduled for 15<sup>th</sup> September.</li></ul> Cllr Bond asked if we were getting good response from the Public. SA advised that we are hoping the new questionnaire will meet with more response but that the group are looking at alternative ways to reach people, particularly through IT media. Cllr Denness advised on £1000 Grant available for setting up a Speed Watch Group, and asked if this could this be considered through the NP Group.	<b>CO</b>
