| 06/16.10 | Borough Councillors: Cllr Rhatigan - i) Waste - West Berks might limit access to the site at Newtown Road so Basingstoke and Deane and Hampshire County Council are talking to them. ii) Manydown Development - Concerns have been raised about the effects of additional traffic onto the A339 and these have been cited by our Borough Councillors to the project leaders. iii) Boundary Changes (County) – Kingsclere would go into Whitchurch Ward and loose Ashford Hill with Headley. Recess proposed: RG – High hedge obscuring school warning sign of Ashford Hill Road. JB – Who manages website? Clerk to remove item re 'financial impropriety' HD – Parish Paths – 7 volunteers worked on Strokens Farm and a cake was provided – clerk to write thanks. Group are going to work on path behind sewage farm. A 'Dogs' notice found in parish paths shed – GP to look at whole issue. AD – Fieldgate waste facility – crammed full. What arrangements are in place for regular emptying including the Salvation Army banks? War Memorial – a firm estimate of £230 has been received to inscribe the missing name and £100 has already been donated but the Royal British Legion will be seeking funding. | |
